



CAMPING REGULATION

This regulation has been drawn up exclusively in the mutual interest of the guests of the Camping Village. It is therefore necessary to respect it and make it respected. The Management will accept any complaints and will remove from the Camping those who do not comply with it.

The following Regulation is considered known and accepted by Customers in all its parts, without exception, with the simple entry into the Camping.

1. The Management is not required in any way, except in cases of proven urgency, to search for the desired people.

2. In order to guarantee rest for Customers, the barrier at the entrance to the Camping will remain closed from 11:00 PM to 7:00 AM and from 2:00 PM to 4:00 PM. It is therefore forbidden to enter or exit with a motorized vehicle (car, motorbike, camper) during these hours.

3. From 11:00 PM to 8:00 AM and from 2:00 PM to 4:00 PM it is forbidden to use radio, Tv, or any other devices that cause disturbs to other guests. However, during other hours please use it moderately.

4. Silence hours are from 00:00 AM to 08:00 AM

5. It is absolutely forbidden to lights fires for any reason. Violators will be removed from the Camping.

6. It is forbidden to damage the plants and equipment inside the Camping, dig ditches or channels around the tents, unless for reasons of absolute necessity. In this case it is mandatory to restore the original conditions of the land at the end of the stay. Any damages will be charged at the discretion of the Management.



7. There is a specific regulations for boat's owners. All boat's owners must read it. Entry into the campsite constitutes full acceptance of it.

8. Dogs are allowed but must always be kept on a leash. Dogs cannot be left free, unattended and must not disturb other guests. It is forbidden to lead dogs to unauthorized beaches, this is by order of the local Harbor Master's Office. Any damage caused to third parties or property by dogs is the complete responsibility of the owner. There is a specific regulation and entry into the Camping constitutes full acceptance of it.

9. The cleaning of the Camping is entrusted to the education of the Customers. Special containers for separate waste collection are placed in different areas of the Camping. **Separate waste collection is MANDATORY and not optional.** It is therefore prohibited to accumulate waste in other places outside of the dedicated areas.

10. It is mandatory to empty the chemical toilet tank only in the specifically equipped areas. Any offender who is caught freely emptying the box will be reported to the competent authorities and removed from the campsite.

11. It is forbidden to wash any vehicle (cars, motorbikes, campers, caravans and boats) and to leave the taps of any toilet open.

12. The Management is not responsible for any interruption of the municipal water service and electricity supply.

13. It is mandatory to leave the toilets clean and tidy after each use, and to leave them in suitable conditions so that they can also be used by others. The staff in charge will report any non-compliance to the Management.

14. It is forbidden to connect electrical equipment exceeding an amperage of 10A

15. The Management reserves the right to move cars, caravans, campers, tents etc. already placed in the way it deems most appropriate, always with the aim of providing good accommodation for everyone.



16. Customers are asked to take care of their property. The Management is not responsible, in any case, for any missing objects or valuables.

17. Customers are obliged to park their cars and motorbikes in the dedicated parking area, located near the Management, while circulation inside the Camping by any vehicle, must be very slow.

18. Renting a Bungalow, Tukul or a pitch even by just one person will be charged at the rate of 2 persons.

19. Customers are asked to complete the departure operations in the morning. The pitch must be vacated free by 12:00, while the accomodation must be vacated by 10:00. Otherwise, another night will be charged according to the season rate.

The cash desk will be open from 08:00 AM to 12:30 PM and from 17:00 PM to 19:00 PM.

Payment can be made in cash or by credit card (members of the VISA, MASTERCARD, MAESTRO, VPAY circuit).

We do not accept payments with American Express.

20. For the benefit of the community, the Management reserves the right to intervene in all those cases not covered by these Regulations. The staff in charge is required to report any infringement.
